DIRECTIONS:

General Information: Permethrin is a synthetic version of pyrethrins. Pyrethrins have long been known for rapid knockdown of insects. Although permethrin is more stable than pyrethrins, it is still degraded by the ultraviolet rays of the sun. This results in a relatively short residual life in the presence of sunlight. When protected from the sun, permethrin will provide residual/long lasting activity.

How to Apply: Container can be held in any position while spraying, even upside down. **DO NOT APPLY AS A SPACE SPRAY OR BROADCAST APPLICATION.** Apply as a crack and crevice or spot treatment only. Spot treatment is localized to surface area not more than 0.2 m². Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and moldings. Treatment must only be repeated if pest problem persist or reoccurs.

INSTRUCTIONS FOR INSIDE BUILDINGS:

TO KILL ANTS, COCKROACHES, SILVERFISH, SOWBUGS AND SPIDERS:

Affix the white actuator to the spray canister to apply the product as a coarse spray. Thoroughly treat inside building surfaces including cracks, crevices in walls, floors and ceilings; along and behind baseboards; around water pipes and tanks; walls behind and floors beneath appliances (e.g., refrigerators and stoves) and furniture (e.g., shelves, drawers, cabinets and storage units); around sinks, drains and pipes; around garbage containers; around interior foundations; localized area around garbage cans; localized areas of floors and floor coverings and points of entry (e.g., around windows and doors). For silverfish, also spray the cracks and crevices in bookcases. Remove all objects before treatment of bookcases where books, clothing, toys, towels and other items are stored. Treated bookcases must be dry before replacing stored items. For ants, also spray trails and nests. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

OUTDOORS ON THE EXTERIOR SURFACES OF BUILDINGS:

TO KILL ANTS, CRICKETS, FLEAS, SPIDERS, SOWBUGS AND BROWN DOG TICKS:

For use outdoors on the exterior surfaces of buildings. Affix the white actuator to the spray canister to apply the product as a coarse spray. Apply to the outside surfaces of foundations, around light fixtures, and places where listed pests enter (e.g., screens, doors, window frames). For spiders, apply the exterior surfaces of buildings including under awnings and canopies. For (pavement) ants, spray onto ant trails, into ant nests and points of entry. Affix the red actuator to the spray canister to apply the product as a jet spray as far as 17 feet, in order to reach listed pests under eave troughs and eaves. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

RESTRICTIONS: DO NOT USE on humans or animals. DO NOT apply to any body of water. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Avoid application of this product when winds are gusty. DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed. DO NOT apply when people, pets or livestock are present. DO NOT allow people, pets or livestock to enter treated areas until sprays have dried. DO NOT allow spray to drip or allow drift onto non-target surfaces. DO NOT apply to

people, pets, livestock or sources of electricity. Unless otherwise stated on this label, DO NOT apply to furniture (excluding bookcases and storage furniture), mattresses, linens, toys or clothing. When applied indoors, DO NOT apply to overhead areas or in confined spaces (for example, attics, crawlspaces). When applied indoors, ventilate treated areas after application by opening windows and doors or using fans, where required, to aid in the circulation of air. When used on the exterior surface of buildings, DO NOT treat soil, turf or other plants adjacent to the building. DO NOT treat patios, porches, decks, gazebos or play structures.

The application of this product to vinyl and aluminum siding (particularly lightly colored, aged, weathered or otherwise damaged) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Before applying, treat a small area of the siding and evaluate 30 minutes later to allow any potential staining to occur. Regardless of the test results, do not apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of the day. Do not apply to tapestries, wallpaper or similar materials that may be stained. For all other surfaces, test a small inconspicuous area of the surface to be treated for color fastness & staining before full application.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat or store at temperatures over 50°C. Wash thoroughly after handling and before smoking or eating.

ENVIRONMENTAL PRECAUTIONS: Toxic to aquatic organisms, birds, bees and beneficial insects.

FIRST AID: If in eyes: hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses. If present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Have person sip a glass of water if able to swallow. Do not give anything by mouth to an unconscious person. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: When container is empty, press valve to release pressure. Do not puncture or incinerate. Wrap empty container and discard in household garbage.
