## **DIRECTIONS FOR USE**

To be used only in the manufacture of a herbicide which is registered under the *Pest Control Products Act*.

## **PRECAUTIONS**

### **PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.**

Strictly observe all precautions for handling and using pesticides. Harmful if swallowed or absorbed through the skin. Extremely irritating and corrosive to eyes.

Avoid contact with skin, eyes and clothing.

Wear protective goggles or face shield when handling.

## **ENVIRONMENTAL HAZARDS**

TOXIC to aquatic organisms and non-target terrestrial plants.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

## **FIRST AID**

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

## **TOXICOLOGICAL INFORMATION**

Dicamba may cause severe irritation to the eyes and irritation to the skin and mucous membranes. Symptoms of overexposure to dicamba may include dizziness, muscle weakness, loss of appetite, weight loss, vomiting, decreased heart rate, shortness of breath, excitement, tenseness, depression, incontinence, cyanosis, muscle spasms, exhaustion and loss of voice.

Treat symptomatically.

### **STORAGE**

Store in original containers in a well-ventilated, cool, dry and secure area. Ship and store away from food, fertilizers, feed or seed. Keep containers tightly closed. Thaw if frozen. Shake before use.
