Remove protective cap and gently insert the extension tube into the spray nozzle before using. This product is designed for applying into cracks, crevices, or tight areas that are difficult to reach. Thorough applications produce a coating which will vapourize into cracks and crevices for insect control.

**Indoor Use**: For the control of ants indoors, spray directly into cracks and crevices particularly under baseboards where these pests like to go. Spray into hard to reach places, behind refrigerators, washers, under sinks, between cabinets, under counters and other places where these pests hide, such as around door and window frames. Do not spray this product in areas where it can be mopped away.

**Outdoor Use**: For the control of ants outdoors, gently insert (the wand or application wand or the extension tube) as far as possible into cracks and crevices in driveways, patios, sidewalks, or interlocking brick where ants hide. (Pull or Push or Depress (trigger or nozzle) and allow foam to fill the area. Stop spraying when the foam comes back out the crack or crevice. For best results, treat all cracks and crevices in the area where ants are found.
