DIRECTIONS FOR USE

To be used only in the manufacturing, formulating or repackaging of a pesticide which is registered under the **PEST CONTROL PRODUCTS ACT**.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Wear chemical-resistant gloves, long pants, a long-sleeved shirt and shoes when handling this product. Do not contaminate with moisture, organic matter, or any other chemicals. Strong oxidizing agent. May cause fire or explosion if contaminated. Dangerous gas formed when mixed with acid. STORAGE

Keep container closed and store in a cool, dry location. Rinse thoroughly before discarding. Do not re-use.

FIRST AID

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
