This product works well in outdoor areas where there is minimal air movement, such as decks, porches, patios and yards. Use one lantern per each 21.0 square metres (an area 4.5 x 4.5 metres or 15' x 15'). Use more lanterns in larger areas, spacing them to ensure adequate coverage. Wind, heat or humidity may affect the performance of this product. Lantern and mat effectiveness may be diminished if exposed to rain. Make sure that candleholder has been secured by turning it clockwise until it clicks, and that lantern globe is securely on lantern base. [Lantern globe will click into place.] Place lantern on a level stable surface or hang from bail on a stable garden hook. Lantern provides light as it repels and kills mosquitoes.

1. Remove lantern from base by squeezing latch tabs on lantern bottom and pulling out lantern top.
2. Remove [product name] repellent mat and [product name] candle from refill box.
3. Take [product name] repellent mat out of wrapper and insert under grill on lantern top.
4. Place [product name] candle into candleholder with wick upright.
5. While holding lantern base upright, insert [product name] candle and candle holder up through bottom and turn right [clockwise] in direction of arrow [see picture] [as shown in picture] until candle holder clicks into place. **Make sure candleholder clicks into place.**
6. Set lantern base down on a level surface and light candle.
7. Replace lantern on the base. **Be sure to push down on lantern until it clicks [into base].**
8. When finished using lantern, extinguish [product name] candle by blowing into grill top.

To Replace Candle [and] [or] [/] Repellent Mat: Replace [product name] candle and [product name] repellent mat only when lantern is cool and not in use. Remove candleholder from base of lantern by turning [left] [counterclockwise]. Discard used [product name] candle. Insert new [product name] candle. Use only [product name] candles. Other candles may not provide correct amount of heat to release repellent optimally, reducing effectiveness. To replace a used [product name] repellent mat, push the used repellent mat out by inserting a new mat.
