DIRECTIONS FOR USE:

SHAKE WELL BEFORE USING. Depress valve and spray lightly from a distance of 20-25cm (8 to 10 inches). [Use [extension tube] [wand] [applicator] for tight to reach places.] Spray in an inconspicuous area to test for possible staining or discoloration. DO NOT treat bed linens. DO NOT treat clothing. DO NOT use articles until treatment is dry. DO NOT treat pets. Do not use tetramethrin in food handling, storage or preparation areas while food is present. Do not use in commercial food processing or preparation areas. In the home, all processing surfaces should be covered during treatment, or thoroughly washed and rinsed before use.

DO NOT apply as a broadcast application. Use only for spot, perimeter or crack and crevice applications. A spot treatment is made to a localized surface area not greater than 0.2 m². Spots are not to be adjoining and the total area of spots is not to exceed 10% of the surface area being treated (e.g. floors, walls, ceilings). A crack and crevice application is made into narrow openings on the surface of the structure. Such openings commonly occur at expansion joints, utility entry points and between different elements of constructions (e.g. baseboards, moulding). An exterior perimeter/band application of a pest control product is made as a band or strip less than 1 m wide. Residential areas are defined as any use site where the general public, including children, could be exposed during or after application. For structural uses, in residential sites, this includes homes, schools, restaurants, public buildings or any other areas where the general public including children may potentially be exposed. Application to upholstered furniture must be limited to tufts and seams or spot treatment.

FOR INDOOR AND OUTDOOR USE:

FLYING INSECTS: Flies, gnats, mosquitoes, hornets, wasps, whiteflies (indoor plants only), and small flying moths. Close all doors and windows and direct spray upward into center of room with slow sweeping motion. Spray 5 to 10 seconds for average room. Direct mist into areas where insects are present.

CRAWLING INSECTS: Ants, Carpet Beetles, Centipedes, Caterpillars, Cockroaches, Crickets, Fleas, Silverfish, Earwigs, Mealybugs, and Spiders. Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harbouring these pests (e.g. cracks, hidden surfaces under sinks, behind stoves, fridges, etc.). To kill ants, treat doors, around window frames, ant trails and other areas of entry.

HOUSEPLANT PESTS: Kills Ants, Aphids, Caterpillars, Leafhoppers, Spiders, Whiteflies, Mealybugs, and Spider Mites on houseplants such as Ivy, African violets, Impatiens, Geraniums and Begonias. Hold container 45 to 60 cm from plants being sprayed. Cover

upper and lower surfaces of leaves. Avoid wetting foliage with spray. Use short bursts of 1 second for spot application on new growth. Use caution on young plants and new growth. Do not use on Maidenhair Ferns. Not for use in greenhouses, vegetable gardens or on food-bearing plants.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN AND PETS. Harmful if swallowed or absorbed through skin. Contains petroleum distillate. Do not breathe vapours or spray mist. Avoid contact with skin or eyes. Wash hands with soap and warm water after use. DO NOT SPRAY PETS OR OTHER ANIMALS WITH THIS PRODUCT. Cover fish aquariums and remove animals for a minimum of 1 hour when spraying room. Following treatment, ventilate all rooms, do not access for a minimum of 15 minutes and do not re-enter before ventilation is complete. Avoid contact with treated surfaces until dry. Contents under pressure. Keep away from heat, sparks and open flame. Do not puncture or incinerate container. Exposure to temperatures above 50°C may cause bursting. Do not use this product in or on electrical equipment due to possibility of shock hazard.

ENVIRONMENTAL HAZARDS:

Toxic to aquatic organisms. TOXIC to bees. Do not spray bees. This product is intended for use on yellow jackets, hornets and wasps only.

FIRST AID:

If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. **If on skin or clothing**, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **If inhaled**, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. **If in eyes**, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Treat symptomatically. Contains petroleum distillates. Vomiting may cause aspiration pneumonia.

STORAGE:

Store in a cool dry area away from heat or open flame.

DISPOSAL:

Do not use empty container. When container is empty, press button to release all pressure. Wrap container in several layers of newspaper and discard in household garbage. Do not puncture or incinerate.
