DIRECTIONS FOR USE: To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.

PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Wash hands thoroughly with soap and water before eating, drinking or smoking. Remove protective equipment immediately after handling, wash thoroughly and change into clean clothing.

PROTECTIVE CLOTHING AND EQUIPMENT: Wear safety goggles, long pants and long-sleeved shirt, with shoes and socks during handling and clean-up of spills.

FIRST AID: **If on skin or clothing,** take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **If in eyes,** hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If swallowed,** call a poison control centre or doctor immediately for treatment advice. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. **If inhaled,** move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor immediately for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

STORAGE: Light sensitive. Keep container tightly closed. Store in a cool, well-ventilated, and dry area. Do not store below 4°C (39°F) or above 30°C (86°F).
