# **DIRECTIONS FOR USE**

To be used only in the manufacture, formulation, and repackaging of a pesticide registered under the *Pest Control Products Act*.

### PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

### FIRST AID

**If Swallowed:** Call a poison control center or doctor IMMEDIATELY for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.
