Direct tablet contact may cause ble aching of spa s urfaces. Automatic feeding devices employing these tablets must be totally free from traces of other spa sanitizers to avoid the probability of an explosion.

Maintain recommended daily levels as determined by testing kit. 1

# Free available chlorine: 3.0 – 5.0 ppm pH: 7.2 – 7.8 Total alkalinity: 125 – 150 ppm

Calcium hardness: 150 – 200 ppm

- Superchlorinate a freshly filled spa by adding 20 g of MINI TABS per 1,000 L of spa water. Maintain water circulation at least 1 hour before en tering the spa ( always measure your free av ailable chlorine level before u sing the spa to make sure it falls within the 2. recommended levels). Repeat superchlorination procedure after each use period.
- If us ing an au tomatic c hlorinator, fill the chamber with M INI T ABS tablets and adjust flow rate, according to ma nufacturer's 3. recommendations to maint ain proper chlorine residual. Adding tablets to the spaskimmer basket is an alternative chlorine feed method.
- Maintain proper chlorine residual by adding 10 g of MINI TABS per 1,000 L of spa water, daily or as needed.
- Persistent foa m formation, turbid, or malodorous water are indicators of in adequate sanitizer levels. To correct such conditions, superchlorinate spa water by adding 30g of MINI TABS per 1,000 L of spa water. Maintain circulation at least 1 hour and wait four 5. hours be fore using (always mea sure y our fre e av ailable chlorine lev el befor e using the spa to make s ure it falls within the recommended levels).
- Note on Superchlorination: MINI TABS contains stabilizer (cyanuric acid) which will accumulate in spa water. Use of MINI TABS for 6. superchlorination will raise stabilizer level at a faster rate. Keep stabilizer level within 30-100 ppm range by dilution with fresh water. Superchlorination with MINI TABS will also lower total alkalinity. Make sure that the total alkalinity stays within recommended levels.
- NOTE: Maximum spa water usage temperature is 40 °C. Ba there should not stay more than 15 minutes in spa water at 40 °C. For proper sanitation, spa must be completely drained periodically. The number of days between COMPLETE SPA DRAINAGE is equal to the volume of spa water in litres, divided by 10 times the maximum number of daily spa u sers. Refill spa with water and repeat 7. DIRECTIONS FOR USE.

### PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. Strong oxidizing agent. May cause fire or explosion if contaminated. Dangerous gas formed when mixed with acid. Do not mix with any other chemical. It is recommended to wear rubber gloves when handling this product. Avoid contact with skin and eyes. Harmful if swallowed. Keep container closed and store in a cool, dry location. DISPOSAL
