Ortho® Ant B Gon™ Max Ant & Roach Killer Gel incorporates boron (in the form of disodium octaborate tetrahydrate) in a special food bait which is highly attractive to ants, carpenter ants and cockroaches. Ants and carpenter ants will return to their nests after consuming the bait and will feed their young and the queen, destroying the colony. Cockroaches will feed directly on the bait and die, but will not share the bait. The boron works slowly and sufficient bait should be made available for at least 14 days of continuous feeding. Repeat placement of the bait until satisfactory control has been achieved.

Do not use sprays, foggers or any chemicals or cleaners near the bait placements. This may contaminate the bait and cause the insects to cease feeding.

For control of ants, carpenter ants and cockroaches, use indoors or outdoors in and around homes, apartments and condominiums.

DIRECTIONS FOR USE:

Remove a syringe from the package and inject gel into cracks and crevices around windows and doors, inside and out, along baseboards, in dead spaces or any other tight space where the bait is protected from exposure and inaccessible to children and pets.

PRECAUTIONS:

Apply/use only in areas inaccessible to children and pets. KEEP OUT OF REACH OF CHILDREN AND DOMESTIC ANIMALS. Avoid contamination of water, foodstuffs and utensils. Wash hands after use.

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. IF ON SKIN/CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. Take the container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Treat symptomatically.

DISPOSAL:

Do not reuse empty container. Wrap empty container and discard in household garbage.
