DIRECTIONS FOR USE**MARENGO ADJUVANT FOR USE WITH MARENGO HERBICIDE**

Marengo Adjuvant is a spray tank adjuvant for use with Marengo Herbicide for post-emergent control of grasses in small grain cereal crops.

Application Rates

Apply Marengo Adjuvant at a rate range of 0.5 to 1.0% V/V (5 L Marengo Adjuvant /1000 L spray mixture to 10 L Marengo Adjuvant /1000 L spray mixture). The higher rate is for use under adverse conditions, such as dense weed population, late weed growth stage, or poor environmental conditions, or with certain multiple product tank mixes. Refer to the herbicide product labels for additional details on rate of use and for mixing instructions.

Tank Mixtures

When tank-mixes are permitted, read, and observe all label directions, including rates and restrictions for each product used in the tank-mix. Follow the more stringent label precautionary measures for mixing, loading, and applying stated on both product labels.
