### **FIRST AID:**

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**STORAGE:** Keep container closed and store in a cool, well-ventilated area. Do not contaminate food or feed by storage or disposal or cleaning of equipment.

## **DIRECTIONS FOR USE:**

**Initial dosage:** Add 135 mL of **HTH Algae Guard 15** per 10,000 litres of pool water.

**Weekly maintenance dosage:** Add 70 mL of **HTH Algae Guard 15** per 10,000 litres of pool water.

**Visible Algae Dosage:** The best way to rid your pool of visible algae is to add a shock treatment or use a higher dosage of **HTH Algae Guard 15**. If using a shock product, superchlorinate following label instructions of shock product employed and wait for at least 24 hours before adding weekly maintenance dosage. If superchlorination is not employed, add 340 mL **HTH Algae Guard 15** per 10,000 litres of pool water.

DO NOT apply when swimmers are in the immediate vicinity (a 15-minute restricted-entry interval is recommended).
