DIRECTIONS FOR USE:

(Twist to) open (metal) (tin) container.

Remove coil from (pouch) (container) (box). Use one coil for each (3m x 3m) (9 square metre) area.

(Select (a) tray and bend (position) (lift) tab (metal tab) (pin) (holder) (stand) (coil support) (to upright position))

Align coil with (metal) tab (pin) (holder) (stand) (coil support). Insert (press) (mount) (snap) the slot of the coil onto the tab (metal tab) (pin) (holder) (stand)(coil support).

Light outer end of coil until (glowing) (it glows), then BLOW OUT ANY FLAME.

Each coil lasts up to 4 hours.

If shorter period of use is desired, carefully lift (remove) coil from the tab (metal tab) (pin) (holder) (stand)(coil support) and extinguish (by pressing the glowing end inside the container (against the tray). The unused portion can (then) be (stored within the (metal) (tin) container and) relit when needed.

(Squeeze sides of metal tab (pin) (stand) (coil support) and fold down to store tray (inside the container).)

(Save the tray (holder) (stand)(coil support) (and container) for use with OFF! Coil Refills ([brand name]). (When repellent coil is completely exhausted (used), save the tray (holder) (stand) (coil support) (and container) for future use with OFF! Coil Refills ([brand name]).

Remove coil from (pouch) (all wrapping materials) (container) (box) (envelope). (Loosen outer rings until end moves freely.) (Grasp each COMMA shaped portion in the center between thumb and forefinger of each hand.) (Separate the two COMMA shaped portions by gently pressing them in opposite directions ½ cm apart.) (Select (a) (coil) tray and (bend) (position) (metal) (plastic) (pin) (tab) (holder) (stand)(coil support) (to upright (vertical) position))

Align coil with (mounting) (spring) (pin) (tab) (holder) (detail) (stand) (device) (tray) (spring) (metal) (plastic) (pin) (coil support). Insert (press) (mount)(snap) the slot of the coil onto (into) the (spring) (metal) (plastic) (pin) (coil support) (metal stand (in the base of the pot.)

Light outer end of coil until glowing (it glows), then BLOW OUT ANY FLAME.

(Restore lid) (slide tray into unit)(align lid to base)(snap lid to base) (and) place (unit)(pot)(device)(coil)(trays) (s). Use one coil for each (3m x 3m) (9 square metre) area.
