1. Stand serves as a holder for the coil. Pull center piece to upright position. Each disc consists of two (2) coils that should be separated.
2. Loosen outer rings of coil until end moves freely.
3. Grasp each comma-shaped portion in the center between thumb and forefinger of each hand.
4. Separate the two comma-shaped coils by gently pressing them in opposite directions 5 mm. apart.
5. Hold one comma shaped end and shake lightly or gently pry apart to separate the coils.
6. Insert tip of coil stand into slot in comma shaped end of coil.
7. Light outer end of coil until glowing.
8. Blow out any flame and allow to smolder.
9. Place one coil per 9 m<sup>2</sup> in area where mosquitoes are to be repelled.

**DO NOT** use in windy areas. Use in outdoor areas, including backyards, patios, porches and decks, which are sheltered from effects of wind and more easily protected by coils. In light winds, place coils upwind where possible to make use of associated drift. If shorter periods of
