## GENERAL INFORMATION

**PURGE III** is to be used in the control of flies, mosquitoes, gnats, and small flying moths in:

- A. Food service and preparation areas;
- B. Food processing plants;
- C. Stores, supermarkets, warehouses, nursing homes;
- D. Farms, barns, dairies, milk and egg handling areas of dairies and chicken houses.

## DIRECTIONS FOR USE

### RESTRICTIONS

- Do not use in dwellings (e.g., houses, apartments) in rooms attached to dwellings (e.g., garage, basement), schools, daycare centers, hospital wards, guest rooms of hotels, motels, and resorts or any area where children may spend more than 4 hours in a day.
- DO NOT apply when a food/feed processing facility is in operation.
- Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash following treatment.
- Application on livestock intended for food production is prohibited.

**PURGE III** is engineered for use in automatic metered dispensers. The dispenser automatically activates the special metered valve every 15 and/or 30 and/or 45 minutes. Recommended use is for 24 hours: but if less than 24 hour use is required, the dispenser should be set to start one hour before control is desired and run one hour after control is no longer needed. It is suggested that the dispenser be changed at least once a month.

Factors such as airflow rate, size of space treated, humidity and room temperature affect insect activity and control. Therefore, one unit per 6,000 cubic feet of unobstructed space should be considered as an average with adjustments made depending on specific conditions at usage site.

1. Remove protective cap from top of can and insert can in dispenser.
2. Suspend dispenser 2-3 meters from the floor and at a point where wind flow will carry the particles throughout the room.

As with any method of insect control, best results are achieved when sanitation and other positive insect prevention practices are followed.

### PRECAUTIONS

- **KEEP OUT OF REACH OF CHILDREN.**
- **CAUSES SKIN IRRITATION, POTENTIAL SKIN SENSITIZER.** Avoid contact with skin and inhalation of spray mist. Do not use in nurseries or rooms where infants, ill or aged persons are confined.
