DIRECTIONS FOR USE: SHAKE WELL BEFORE USING. Apply with hand trigger sprayer attached. Depress button on top and adjust nozzle to suitable spray pattern. Spray to thoroughly wet plants. Controls Powdery Mildew, Rust, Black Spot, Scab and certain mites.

Roses, Flowers, Ornamentals: Rust, Powdery Mildew, Black Spot, Mites. Spray every 7-10 days through the season.

Beans, Peas: Powdery Mildew, Rust. Spray on appearance of disease and repeat at 7-10 day intervals as necessary.

Currants and Gooseberries: Powdery Mildew, Rust. Apply before earliest blossoms and continue through harvest.

Strawberries: Powdery Mildew. Apply at first sign of mildew and repeat every ten days if necessary.

Preharvest Interval: May be used up to one day before harvest.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not apply at temperatures 24°C or higher such as in locations in direct sun and during midday heat, or within 30 days of oil sprays. Do not contaminate feed or food. Avoid breathing spray mist and contact with skin, eyes and clothing. Wash thoroughly after use.

ENVIRONMENTAL HAZARDS: Do not apply directly to aquatic habitats (such as lakes, rivers, sloughs, ponds, coulees, prairie potholes, creeks, marshes, streams, reservoirs and wetlands) and estuarine/marine habitats. Do not contaminate water by cleaning of equipment or disposal of wastes.

FIRST AID: If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. **If in eyes,** hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If on skin or clothing,** take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. Take container, label or product name and P.C.P. Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: Do not reuse empty container. Wrap and dispose of empty container with household garbage.
