DIRECTIONS FOR USE

Wilson® Predator™ Sonic Max produces ultrasonic waves in a frequency range of 30 to 50 kHz at 120-126 dB from the ultrasonic device.

Wilson® Predator™ Sonic Max should be used in rooms where signs of mouse or rat activity is observed. Simply plug the device into an unobstructed wall outlet in the room to be protected by ultrasonic sound. Placement of the ultrasonic device is important.

Ultrasonic waves travel in a straight line and bounce off non-absorbing materials to fill a room. Hard surfaces such as walls, mirrors, cupboard doors, and appliances will reflect ultrasonic waves. The area covered by the ultrasonic waves may be better when there are more reflective surfaces around the exterior walls of the room where the ultrasonic device is located. Leaving interior doors open will allow ultrasound to travel outside of the room.

Ultrasound cannot penetrate through hard objects (e.g., walls, doors, furniture). Mice or rats behind such objects will not be repelled. Sound absorbing materials such as carpets, drapes and soft furniture will also reduce the ultrasonic range of the device. Areas where the ultrasonic sound waves may not penetrate includes but is not limited to corners, nooks and crannies, behind furniture, walls and doors.

Ultrasound will be stronger closer to the device and in the room where the device is placed. More units are required for larger rooms and in multi-storey homes.

PREVENTATIVE METHODS FOR CONTROLLING RATS AND MICE

The problem of mice and rats entering the home can be reduced by limiting their access to food and water. Keep a lid on your kitchen garbage. Keep any loose food in airtight containers. Do not keep pet food or water out overnight in your home. Repair plumbing leaks and drain the liquid from cans and bottles that you may be storing in your home before you recycle them. Don't let extra cardboard boxes, paper bags, old magazines, or newspapers accumulate in your home as they may provide additional nesting places for pests.

Don't allow tall grass, thick ground cover, mulch, or piles of leaves to accumulate next to the foundation of your home. Mice and rats may establish themselves in these areas and this increases the chances of them entering your home. Keep shrubs and tree branches away from your home, as this allows another pathway indoors for mice and rats. Screen all vent openings, including crawl spaces, attics, or laundry vents. Cracks around the edges of doors and windows should be repaired. Make sure window screens are fitted properly and doors are weather stripped to prevent mice and rats from entering through these areas.

CAUTION! This product is intended for use indoors only. To avoid risk of fire or electric shock, do not use where it may be exposed to water or direct sunlight, including roofed, but open porches.
