DIRECTIONS FOR USE: FOR INDOOR USE AT BUILDINGS, FOR OUTDOOR USE ON THE EXTERIOR SURFACES AND AROUND LISTED BUILDINGS AND PORCHES.

Provides a fogging action over a large area and kills flies, mosquitoes, wasps and hornets. To enhance effectiveness of this product, apply directly to the listed pests where possible. For all labelled uses, treatment must only be repeated after 7 days if pest problem persists or reoccurs. When applied indoors, good sanitary practices should be maintained to prevent re-infestation.

How to apply: DO NOT APPLY AS AN INDOOR SURFACE TREATMENT. Apply as an indoor or outdoor space spray or outdoor broadcast treatment only. **Indoor space application** is a suspension of fine droplets in the air within an indoor space. **Broadcast application** is to large outdoor structural surfaces (roofs, walls, doors, windows and foundations). **DO NOT** apply when people or pets are present. **DO NOT** allow people or pets to enter treated areas until sprays have settled or dried.

INDOOR USE: To control house flies, hornets, mosquitoes, and wasps: Adjust nozzle to deliver the mist spray pattern. Close all windows and doors and shut off all ventilating systems and sources of ignition before treatment. While holding can at arm's length, spray upward to all parts of the room, especially ceiling, upper corners of the room, windows and other light sources. Keep spray at least 1 m from interior walls, fabrics and furniture. Begin application at far side of the room and work backwards toward exit. **DO NOT** exceed 2 seconds per 10 m³. Vacate the treated area and keep windows and doors closed for 15 minutes, then ventilate treated areas by opening windows and doors or using fans, where required, to aid in the circulation of air.

OUTDOOR USE: To control house flies, hornets, mosquitoes, and wasps: Adjust nozzle to deliver the mist spray pattern. **DO NOT** apply to overhead areas or in confined spaces (e.g., eaves, soffits). **DO NOT** allow spray to drip or allow drift onto non-target surfaces.

- **For use on the exterior surfaces of listed buildings:** Apply to structural surfaces of homes, garages, storage buildings, barns, domestic kennels, domestic farm buildings, and domestic stables where insects are congregating, including around windows & doors and other structural surfaces of listed buildings. **DO NOT** exceed 15 seconds per m². **DO NOT** treat soil, turf or other plants adjacent to the treatment site.
- **For use around listed buildings and porches:** While holding can at arm's length, direct mist upwards in sweeping motions around listed building and porches. **DO NOT** exceed 4 seconds per m². **DO NOT** apply in areas where plants are grown for food or feed (e.g., vegetables, fruit, herbs).

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid breathing spray mist. Avoid contact with skin, eyes and clothing. Harmful if swallowed, inhaled or absorbed through skin. Not for use on humans. Wash after use. Cover or remove aquaria and remove pets for 1 hour. Wash contaminated clothing before reuse. **DO NOT** use in areas where beekeeping equipment or supplies are stored, or where milk is stored or processed. **CONTENTS UNDER PRESSURE. DO NOT** place in hot water or near radiators, stoves or other sources of heat. **DO NOT** apply to surfaces that may come into contact with food/feed. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash them following treatment. Any food/feed accidentally contaminated with spray solution must be discarded.

STORAGE: Store away from feed and food. Keep from freezing. **DO NOT** store at temperatures over 50°C.

ENVIRONMENTAL PRECAUTIONS: Toxic to aquatic organisms. **DO NOT** apply to any body of water. **DO NOT** contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Toxic to bees. Avoid application around blooming plants. If applications must be made during the blooming period, restrict applications to evening when most bees are not foraging. Toxic to beneficial arthropods (which may include predatory and parasitic insects, spiders, and mites). Minimize exposure to non-target areas. Avoid application of this product when winds are gusty.

FIRST AID: **If in eyes**, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If on skin or clothing**, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **If swallowed**, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. **If inhaled**, move person to fresh air. If person is not breathing, call 911 or an ambulance. Then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Skin exposure may cause transient sensations (tingling, burning, itching, numbness). Other symptoms of exposure could include respiratory effects (such as cough, respiratory irritation, or shortness of breath), nausea, headache or dizziness. Treat symptomatically.
