This insecticide contains the active ingredient spinosad which is derived from a naturally occurring bacterium, *Saccharopolyspora spinosa*. Ants are attracted by the bait and carry it to their nest where it is fed to other worker ants, larvae and the queen. The colony is controlled within 1 to 2 weeks. Kills ants, including carpenter ants.

**USE SITES:** Areas in and around the home where ants are prevalent including on or around decks, patios, balconies, pathways, lawns, around ornamental plants, trees and landscaped areas and in crawlspaces. Use in homes, garages, and any place there are ants: around baseboards, window and door frames, underneath and behind refrigerators, stoves and garbage cans, in and around cabinets and plumbing.

**DIRECTIONS FOR USE:**

1. Press in the two perforated holes on the side of the bait stations with a pointed object such as a nail, screwdriver, scissors, etc.
2. Place bait stations 1.5 to 3 metres apart and use up to 4 bait stations per 15m<sup>2</sup> if ant infestations are low to moderate. For severe infestations use up to 9 bait stations per 15 m<sup>2</sup>.
3. Place the station near ant nest or where ants are visible. Avoid placing in direct sun to decrease evaporation of the bait solution
4. Check station regularly, and replace when bait solution has been consumed or dried out.
5. Once ants are controlled replace bait stations every three months to prevent new infestations.
6. Alternatively, when ant nest is controlled, remove and dispose of according to the Storage and Disposal instructions.
7. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.** Do not try to open the station. Keep and place bait stations in areas inaccessible to children and pets.
