DIRECTIONS FOR USE

General Information: Permethrin is a synthetic version of pyrethrins. Pyrethrins have long been known for rapid killing of insects. Although permethrin is more stable than pyrethrins, it is still degraded by the ultraviolet rays of the sun. This results in a relatively short residual life in the presence of sunlight. When protected from the sun, permethrin will provide residual/long lasting activity.

Within the specified use location, to enhance effectiveness of this product, apply this product directly to the Ants, Bed Bugs, Cockroaches, Earwigs, Spiders, Sowbugs, Silverfish, Fleas, Brown Dog Ticks, House Flies, Carpet Beetles, Crickets, Firebrats, Red Flour Beetles and Rice Weevils.

Restrictions: DO NOT apply to any body of water. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Avoid application of this product when winds are gusty. DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed. DO NOT apply when people or pets or livestock are present. DO NOT allow people or pets or livestock to enter treated areas until sprays have dried. DO NOT allow spray to drip or allow drift onto non-target surfaces. DO NOT apply to people, pests, livestock and sources of electricity. Unless otherwise stated on this label, DO NOT apply to furniture (excluding bookcases and storage furniture), mattresses, linens, toys or clothing. Apply as a crack and crevice, spot or void treatment only to kill/control listed pests. <u>Spot treatment</u> is localized to surface area not more than 0.2 m2. Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room. <u>Crack and crevice</u> is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings. <u>Void application</u> applies to inaccessible, enclosed empty spaces of a structure.

GENERAL DIRECTIONS

SHAKE CONTAINER WELL. Gently insert the wand or applicator wand or extension tube or applicator hose or jet tube into the spray nozzle before using. This product is designed for applying into cracks, crevices, or voids that are difficult to reach and where the insecticide won't be mopped away. The foaming action of this formula completely fills tight crevices leaving an insecticidal active residue. Good sanitary practices should be maintained to prevent re-infestation.

Instructions for inside buildings:

<u>To Kill Ants, Cockroaches, Earwigs, Sowbugs, Spiders, and Silverfish, and to control Crickets, Firebrats, Red</u> <u>Flower Beetles and Rice Weevils:</u> Thoroughly treat inside building surfaces, including cracks, crevices in walls, floors and ceilings; along and behind baseboards; around water pipes and tanks; walls behind and floors beneath appliances (e.g., refrigerators and stoves) and furniture (e.g., shelves, drawers, cabinets and storage units); around sinks, drains and pipes;, around garbage containers; around interior foundations; localized area around garbage cans; localized areas of floors and floor coverings and points of entry (e.g., around windows and doors). For silverfish, also spray the cracks and crevices in bookcases. Remove all objects before treatment of bookcases where books, clothing, toys, towels and other items are stored. Treated bookcases must be dry before replacing stored items. For ants, also spray trails and nests. <u>To Control Carpet Beetles:</u> Spray edges of carpeting and under carpeting and rugs for approximately 10 seconds duration. Make localized application to floor and baseboards. Spray directly into cracks, crevices and infested areas of shelving. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

<u>To Kill House Flies:</u> Spot treatment only. Spray inside building surfaces around points of entry (e.g., screen frames, doors and window frames), around light fixtures and to localized areas of walls, floors and ceilings. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

<u>To Control Fleas (Adult and Larvae) And Brown Dog Ticks (Adult and Nymphs):</u> DO NOT apply to furniture, mattresses, linens, toys or clothing. Apply to indoor building surfaces, including cracks and crevices in walls and floors, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings. Pet bedding may be entirely treated with this product or replaced with clean, fresh bedding after other listed areas are treated. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. DO NOT spray pets with this product. Only treat pets with products specifically registered for use on that type of pet. For effective flea and tick control indoors, clean any area used by the pet. Cleaning the areas includes vacuuming floors, carpets, furniture, etc. (discard vacuum bag after use) and washing the pet's bedding, living quarters, and surrounding area.

<u>To Kill Bed Bugs</u>: DO NOT apply to the mattress, headboard, footboard or furniture. Apply to inside building surfaces including, cracks and crevices in the walls, floors and ceilings; along and behind baseboards and moldings; and localized areas of walls behind and floors beneath furniture (e.g., bed and nightstand). To enhance effectiveness of this product, apply this product directly to bed bugs where possible. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

Outdoors on the exterior surfaces of buildings and patios, porches, and decks:

<u>To Kill Ants, House flies, Sowbugs, and Spiders, and to control Brown Dog Ticks, Crickets and Fleas:</u> For use outdoors on the exterior surfaces of buildings and on patios, porches and decks. Apply to the outside surfaces of foundations, under eaves troughs, around light fixtures, and places where listed pests enter (e.g., screens, doors, window frames). This product may also be applied to garbage cans and localized areas of patios, porches and decks. For house flies, apply as a spot treatment only. [Houseflies will be killed when they land and crawl on the treated surfaces. For ants, spray onto ant trails, into ant nests and points of entry. For spiders, apply to the exterior surfaces of buildings and on patios, porches and decks including under eaves, awnings and canopies. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

General outdoor:

<u>For Ants in Non-Crop Areas:</u> Apply directly into ant hills. Gently insert the (wand or applicator wand or extension tube or applicator hose or jet tube) as far as possible into hills, mounds, cracks, crevices, fissures, gaps, voids and trails in driveways, patios, sidewalks, or interlocking brick. (Pull or Push or Depress) (trigger or nozzle) and allow foam to fill the area. Stop spraying when the foam comes out.

PRECAUTIONS
