DIRECTIONS FOR USE: For Industrial Use Only as a Preservative Intended to Protect Polymer Emulsions, Paints and Coatings, Mineral Slurries and Dispersions, Latices, Adhesives, Building and Construction Compositions.

Mergal®758 is an effective preservative for use in the above mentioned materials to control growth of bacteria and fungi. Use rate is 0.4% wt/wt of Mergal®758 in the finished product (0.5-4 kg of Mergal®758 per 1000 kg of finished product). Trials are suggested in order to determine the most effective use level within the label rates of Mergal®758.

Mergal®758 may be incorporated at any stage of the production process. For best results, Mergal®758 should be added as early in the production process as possible. If high temperatures or highly alkaline pH values are expected during production, the product should be added after these conditions are controlled.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN AND PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Corrosive to the eyes and skin. Harmful if swallowed. Potential skin sensitizer. Do not get in eyes, on skin or on clothing. Wear chemical resistant coveralls over a long sleeved shirt and long pants, chemical-resistant gloves, socks, chemical resistant footwear and a full face NIOSH-approved respirator during mixing, loading, application, clean up and repair. Avoid contamination of food. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Remove and wash contaminated clothing before reuse.

FIRST AID:

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

IF INHALED: Move person to fresh air. If person is not breathing call 911 or an ambulance, then give artificial respiration preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed. Take medicinal carbon. Avoid alcohol.
