DIRECTIONS FOR USE:

Shake well before using. Apply sparingly, not under clothing and only when necessary. TO APPLY TO FACE: Spray hands and apply avoiding eyes and mouth. Do not spray directly on the face. Do not spray in enclosed spaces. For continued protection from mosquitoes, biting midges, and ticks, re-apply after 2 hours or for black flies, re-apply after 5 hours. Earlier re-application may be necessary after swimming, perspiration, vigorous activity or toweling. Do not apply more than 2 times per day. Do not apply to cuts or irritated skin. Wash contaminated clothing before reuse. After returning indoors, wash treated skin with soap and water.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN AND PETS. May irritate eyes. If skin irritation or other adverse effects develop, wash with soap and water immediately and discontinue use. FIRST AID:

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
