SIDE PANEL

NOTICE TO USER: This pest control product is to be used only in accordance with the directions on the label. It is an offence under the *Pest Control Products Act* to use this product in a way that is inconsistent with the directions on the label.

Provides a fogging action over a large area and kills flies, mosquitoes, wasps and hornets.

FIRST AID:

DIRECTIONS FOR USE: SHAKE WELL BEFORE USING.

The application of this product to vinyl and aluminum siding (particularly lightly colored, aged, weathered or otherwise damaged) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Always pre-test a small inconspicuous area to be treated, for colour fastness and staining. Evaluate 30 minutes after test application for potential staining. Regardless of the test results, **DO NOT** apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of the day.) Within the specified use location, to enhance effectiveness of this product, apply directly to the listed pests where possible. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

Spray only when air is still and temperature is under 32⁰C. Hold can at arm's length with nozzle pointed away from you at a slight downward angle. Stand at least 2 metres from area where listed insects are a nuisance, directing fog toward surrounding bushes and grass. Fog will extend up to 6m from nozzle. Treat beyond the immediate area where control is desired to achieve longer control. **DO NOT** exceed 6.25g of Spray-Pak GARDEN AND PATIO FOGGER per m² (4.2 seconds/m²).

PRECAUTIONS: KEEP OUT OF THE REACH OF CHILDREN. **DO NOT** puncture or incinerate.
