DIRECTIONS FOR USE:

Rodents Away Odor Free reduces house mouse (*Mus musculus*) presence and activity. House mice tend to travel along walls; therefore, sachets are best located on the floor along walls, in confined places, by gnawed openings, and on either side of doorways to rooms.

Clean areas where house mouse activity is observed. Remove individual cloth bags (sachets) from the plastic resealable pouch and place at approximately 3 m (10 ft) intervals throughout the areas where there is house mouse activity. If house mouse activity is present in a confined place, such as in a cupboard, position one sachet within each space (one per 114 L volume).

Check every two weeks for evidence of house mouse activity or other indications of presence. Replace sachets as necessary, or if house mice return. Provide an exit/opening during early stages (24-48 hrs) of treatment to allow house mice the opportunity to vacate. If small holes are observed in the structure, plug or repair these openings once house mouse activity has ceased to prevent further house mouse infiltration.

PRECAUTIONS KEEP OUT OF REACH OF CHILDREN

Wash thoroughly with soap and water after handling.

FIRST AID
