DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

HARMFUL IF SWALLOWED

AVOID INHALING OR CONTACT WITH SKIN AND EYES.

When handling this product, wear coveralls over a long-sleeved shirt, long pants and chemical-resistant gloves.

ENVIRONMENTAL PRECAUTIONS:

Do not contaminate water intended by cleaning of equipment or disposal of wastes. Do not contaminate water used for irrigation or domestic purposes. Toxic to small mammals, birds, aquatic organisms and non-target terrestrial plants.

FIRST AID:

IF SWALLOWED: call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING: take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF IN EYES: hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take the container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

No specific antidote. Treatment should be based on judgement of the physician in response to reactions of the patient. This product may cause mild irritation to the eyes. Overexposure to 2,4-D may cause coughing, burning, dizziness or temporary loss of muscle coordination. Other possible effects of overexposure include fatigue, muscle weakness or nausea. Treat symptomatically.

STORAGE:

Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed, feed, fertilizer or other pesticides. Keep away from fire, open flames or other sources of heat.

DISPOSAL:

Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal or provincial regulations. For additional details and clean-up of spills, contact the manufacturer or the provincial regulatory agency.

CLEAN-UP INSTRUCTIONS

Cover spillage with an industrial absorbent or sawdust. Sweep up thoroughly and place in a labelled container for safe disposal. Avoid entry of the material into sewers or watercourses.
