**PRECAUTIONS**

**PREVENT ACCESS BY UNAUTHORIZED PERSONNEL**

**TOXICOLOGICAL INFORMATION**

**NOTE TO PHYSICIAN:** If ingested, induce emesis or lavage stomach. Treat symptomatically.

**FIRST AID**

**IF IN EYES:** Hold eyes open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**GENERAL:** seek medical attention immediately if toxicity/irritation persists or is severe. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**STORAGE AND DISPOSAL**

**STORAGE:** Store in original container only, in a cool, dry, locked area. Store separately from other pesticides, fertilizers, food or feed to prevent contamination.
