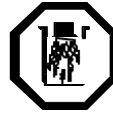

DIRECTIONS FOR USE:

For manufacturing use only. TEE-100A is a TECHNICAL for formulating purposes only. Formulators are responsible for their own registrations.

This product should **not** be used or compounded with any reducing or oxidizing agents (such as calcium hypochlorite, solid perchlorate or nitric acid) since such mixtures may be explosive. Do not use in conjunction with soap or any anionic wetting agent. Wear goggles or face shield, rubber gloves and respirator if mist is generated. Under certain conditions, the use of protective creams may be advisable. Wash thoroughly after handling.

PRECAUTIONARY STATEMENTS:

Keep Out of Reach of Children. Danger - Corrosive to eyes. Do not get in eyes, on skin, or on clothing. Harmful if swallowed. Avoid contamination of food.

FIRST AID:

In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. In case of contact with skin, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.

NOTICE TO USER:

This pest control product is to be used only in accordance with the directions on the label. It is an offence under the Pest Control Products Act to use this product in a way that is inconsistent with the directions on the label.

DISPOSAL:

1. Rinse the emptied container thoroughly and add the rinsings to the treatment site.
