DIRECTIONS FOR USE

Note: Add CSI-7111 separately to the system. Do not mix it with other additives in order to avoid decomposition of CSI-7111 due to the high pH of many additive formulations.

PAPER MILLS

For the control of bacterial, fungal and yeast growth in pulp, paper and paperboard mills,

add CSI-7111 at the rate of 250-875 mL/tonne of pulp or paper (dry basis). Addition may be continuous or intermittent, depending upon the type of system and the severity of contamination. It should be made with a metering pump at a location that will insure uniform distribution of CSI-7111 in the mass of fiber and water, such as the beaters, jordan inlet or discharge, broke chests, furnish chests, save-alls and white-water tanks.

Heavily fouled systems should be boiled out, then treated with 250-625 mL CSI-7111/tonne of paper (dry basis), as necessary for control.

Moderately fouled systems should be treated continuously with 625-875 mL CSI-7111/tonne of paper (dry basis) until the slime accumulation is controlled. Addition rates can then be reduced to 250-625 mL CSI-7111/tonne of paper on a continuous or intermittent basis as needed for control.

Dislodged slime may cause breaks in the paper and a clean-up of the paper machine may be advisable. Slightly fouled systems should be treated continuously with 250-625 mL CSI-7111/tonne of paper (dry basis) until the slime is controlled, then added on an intermittent basis to maintain control.

INDUSTRIAL RECIRCULATING WATER COOLING TOWERS

This product is for recirculating water systems only

Add CSI-7111 to the basin (or any other point of uniform mixing). Addition should be made with a metering pump; it may be continuous or intermittent, depending on the severity of the contamination when treatment is begun, and the retention time in the system.

Optimum performance with this product is attained by continuous or intermittent treatment. If "shock" treatment is used, the blowdown should be discontinued for 24 to 48 hours.

FOR CONTROL OF BACTERIA Add 4-40 mL CSI-7111/1,000 L of water in the system, depending on the severity of contamination.

INTERMITTENT OR SLUG METHOD Initial Dose: When the system is noticeably fouled, add 20-40 mL CSI-7111/1,000 L of water in the system. Repeat until control is achieved.

Subsequent Dose: When microbial control is evident, add 10-40 mL CSI-7111/1,000 L of water in the system every 4 days, or as needed to maintain control. Badly fouled systems must be cleaned before treatment is begun.

CONTINUOUS FEED METHOD Initial Dose: When the system is noticeably fouled add 20-40 mL CSI-7111/1,000 L of water to the system. Subsequently, maintain this level by pumping a continuous feed of 2-20 mL CSI-7111/1,000 L of water in the system lost by blowdown.

FOR CONTROL OF ALGAE Add 125-375 mL CSI-7111/1,000 L of water in the system, depending on the severity of the contamination.

INTERMITTENT OR SLUG METHOD Initial Dose: When the system is noticeable fouled, add 200-375 mL CSI-7111/1,000 L of water in the system. Repeat until control is achieved. Subsequent Dose: When algae control is evident, add 125-375 mL CSI-7111 /1,000 L of water in the system daily, or as needed to maintain control. Badly fouled systems must be cleaned before treatment is begun.

CONTINUOUS FEED METHOD Initial Dose: When the system is noticeably fouled, add 200-375 mL CSI-7111/1,000 L of water to the system.

Subsequent Dose: Maintain this treatment level by pumping a continuous feed of 125-375 mL CSI-7111/1,000 L of water in the system per day.

Badly fouled systems must be cleaned before treatment is begun.

STORAGE

To maintain product quality, store at temperatures below 35°C. Keep package tightly closed when not in use.

DISPOSAL

- 1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
- 2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
