PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

CORROSIVE TO EYES AND SKIN. POTENTIAL SKIN SENSITIZER. MAY CAUSE ALLERGIC SKIN REACTION. FATAL OR POISONOUS IF SWALLOWED OR ABSORBED THROUGH THE SKIN. MAY BE FATAL IF INHALED.

Do not get in eyes, on skin or on clothing. Do not swallow. Avoid breathing vapours and spray mists. Wash skin thoroughly with soap and water after handling.

Remove contaminated clothing immediately, wash skin thoroughly with soap and water, and put on clean clothing. Wash contaminated clothing separately from other laundry before reuse. Discard clothing or other absorbent materials that have been drenched or heavily contaminated with this product.

FIRST AID
