PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

May irritate eyes and skin. Avoid contact with eyes and skin.

May irritate respiratory tract. Avoid inhaling/breathing any dust.

Use only in well ventilated areas.

During handling, mixing, loading, clean-up or repair of equipment, personnel should wear goggles or a face shield, chemical-resistant gloves, long-sleeved shirt, long pants, shoes, and socks. Personnel should also wear a NIOSH-approved N95 (minimum) filtering facepiece respirator (dust mask) that is properly fit tested when handling Potassium Chloride Technical. For good hygiene practice, if clothing has been contaminated, remove it and launder it with detergent and hot water as soon as possible separately from other clothing. Clean personal protective equipment upon removal with soapy water.

For good hygiene practices wash hands and face before eating, drinking, chewing gum, using tobacco, as well as using the toilet. Take a shower immediately after work.

FIRST AID:

If swallowed	Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person
If on skin or clothing	Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 - 20 minutes. Call a poison control centre or doctor for treatment advice.
If inhaled	Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
If in eyes	Hold eye open and rinse slowly and gently with water for 15 - 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Treat symptomatically.

STORAGE:

Store in suitable containers made of plastic, mild steel, fiberglass, or stainless steel. Store in a tightly closed container and away from incompatible substances. Store in a dry, cool, and well-ventilated area.

Always use good safety and industrial hygienic practices. Remove contaminated clothing and wash before reuse.

DISPOSAL:
