PRECAUTIONS

Wash hands thoroughly after handling.

Restricted-entry interval(s): DO NOT enter or allow worker entry into treated areas during the restricted-entry interval(s) stated on the label of the pesticide applied in conjunction with Class Act NG.

FIRST AID

GENERAL INFORMATION

Class Act NG, is a low foam formula water conditioning agent (Ammonium Sulfate) and Non-ionic Surfactant Blend.- Class Act NG is formulated to meet the surfactant recommendation for many products requiring the addition of non-ionic surfactant and to use as a water conditioning agent.

DIRECTIONS FOR USE

Shake Well Before Using

GENERAL INFORMATION

Class Act NG may be used at a rate of 1.25-2.5% v/v depending on water hardness. Take water sample to determine water hardness. Control product spray mixtures, their preparation and uses are to be derived from the individual labels for the control products.

STORAGE
