FIRST AID

The rate of **ASTRAL ADJUVANT** Non-Ionic Wetting & Spreading Agent is indicated for the control product spray mixtures or other uses listed below. Control product spray mixtures, their preparation and uses are to be derived from the individual labels for the control products.
