FIRST AID

PRECAUTIONS

KEEP OUT REACH OF CHILDREN.

Avoid contact with eyes and skin. Causes painful stinging or burning of eyes and lids.

Prolonged contact with skin may cause irritation in some individuals. Wearlong-sleeved shirt, long pants, socks and shoes during mixing, loading, applying, clean-up and repair. In addition, wear chemical resistant gloves and face protection (face shield) when handling the concentrate. Do not eat, drink or smoke when using. Wash hands before meals and after work.

STORAGE

Keep in original container tightly closed in a safe place when not in use. Store in a cool and dry location away from oxidizing and reducing agents. Keep away from heat, sparks and sources of ignition. Keep away from food, drink and animal feedstuffs.

SPILL CLEANUP

Eliminate sources of ignition and ventilate area. Soak up spill with absorbent material (kitty litter, granular clay, earth) and collect into a waste container. Wash spill site with water after material pick-up and dispose with waste. See DISPOSAL statement below.

DISPOSAL OF UNUSED, UNWANTED PRODUCT

For recyclable containers:

For disposal, this container may be returned to the point of purchase (distributor/dealer). It must be refilled by the distributor/dealer with the same product. Do not use this container for any other purpose.
