# **DIRECTIONS FOR USE**

Keysal MSO is a product which enhances the effectiveness of post applied herbicides.

HOW TO MIX: Fill the spray tank about half-full with water and add the required herbicide(s) while the agitator is running or bypass agitation is operating. Complete the filling of the tank with water and finally add Keysal MSO under constant agitation. Refer to specific tank mix herbicides labels for more details.

Add Keysal MSO to a spray mixture when the use of an adjuvant is recommended on the tank mix herbicide label.

# DO NOT APPLY BY AIR.

Apply 1 % v/v or 10 L Keysal MSO per 1000 L of spray mixture as follows:

## **PRECAUTIONS**

KEEP OUT OF REACH OF CHILDREN. PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Wear long-sleeved shirt, long pants, socks and shoes, and chemical-resistant gloves during mixing, loading, application, clean-up and repair.

When applied as a tank-mix combination, read and observe all label directions, including rates, personal protective equipment, restrictions and precautions for each product used in the tank- mix. Always use in accordance with the most restrictive label restrictions and precautions.

CAUTION: Do not graze the treated crops or cut for hay; there is not sufficient data available to support such use.

#### **FIRST AID**

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

## **STORAGE**

Container must be tightly closed during storage.

The minimum recommended storage temperature for this material is 4°C (40°F). If allowed to freeze, warm to 21°C (70°F) and shake well.

## **DISPOSAL**

- 1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
- 2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
- 3. Make the empty container unsuitable for further use.
- 4. Dispose of the container in accordance with provincial requirements.
- 5. For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.
