**DIRECTIONS FOR USE:**

To be used only in the manufacture of a plant growth regulator and/or herbicide product which is registered under the Pest Control Products Act, and contains indole-3-butyric acid.

**PRECAUTIONS:**

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Wash exposed skin thoroughly after using. Causes eye irritation. DO NOT get in eyes. Avoid contact with skin or clothing. Avoid inhaling dusts.

**FIRST AID:**

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
