WHY TO USE THIS PRODUCT: For use in feeders, floaters [or] [skimmers], this multifunctional sanitizer kills bacteria and kills and controls algae, and destroys organic contaminants**. This sanitizer will last longer compared to chlorine products such as liquid bleach or calcium hypochlorite, as it contains sunlight-protected chlorine. This product contains blue algae fighting crystals and SUNSHIELD®, which protects chlorine from sunlight so you use less. It provides crystal clear water through enhanced filtration.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.

Fatal or Poisonous if swallowed. Harmful if inhaled. Avoid inhaling/breathing dusts, fumes, and vapours. CORROSIVE to the eyes and skin. DO NOT get in eyes or skin. Potential skin sensitizer. It is recommended to wear rubber gloves and goggles when handling. Users should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Always store this product out of reach of children and pets and away from food and beverages.

FIRST AID:

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for further treatment advice.

TOXICOLOGICAL INFORMATION: Treat symptomatically. Probable mucosal damage may contraindicate the use of gastric lavage.

DIRECTIONS FOR USE: Read entire label and use strictly in accordance with precautionary statements and directions. Silkguard Complete Sticks is for use only in feeders, [or] floaters, or skimmers, [or automatic chlorinators]. Direct [tablet] {or} [stick] {or} [puck] contact may cause bleaching of vinyl or painted pool surfaces. Automatic feeding devices employing these [tablets] {or} [sticks] {or} [pucks] must be totally free from traces of other pool sanitizers to avoid the probability of an explosion.

1. Maintain recommended daily levels as determined by testing kit or test strips. Do not enter the pool if free available chlorine is above 3 ppm.
Free available chlorine: 1.0 - 3.0 ppm
pH: 7.2 - 7.8
Total Alkalinity: 100 - 120 ppm
Calcium Hardness: 200 - 300 ppm
2. For outdoor pools, chlorine residuals can be protected from destruction by the sun's rays by adding 300 g of stabilizer (cyanuric acid) per 10,000 L of pool water to yield the required initial concentration of 30 ppm.
3. Periodic superchlorination of pool water is recommended. Follow label instructions of superchlorinating product being employed.
4. This product contains stabilizer, which can accumulate in pool water. Keep stabilizer within the range of 30 - 100 ppm by dilution with fresh water.
5. If using [a feeder, [or] floater] [or an automatic chlorinator], fill the chamber(s) with

[tablets] [sticks] [pucks] and adjust flow rate, according to manufacturer's recommendations, to maintain proper chlorine residual.¹ [Adding [tablets] [sticks] [pucks] to the pool's skimmer basket is an alternative chlorine feed method.] [Use this product in a skimmer only if the skimmer and the piping between skimmer and pump are plastic.]

Note: The number of [tablets] [sticks] [pucks] to maintain proper chlorine residuals will vary with the number of swimmers, water temperature, rain showers and pump operating time.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

DO NOT apply this product in a way that will result in direct contact with adults, children or pets.

STORAGE: Keep product dry in tightly closed original container when not in use. Store in a cool, dry, well-ventilated area, away from heat, open flame, sunlight and other chemicals.

DISPOSAL: Rinse container thoroughly before discarding. Offer for recycling if available. Do not reuse empty container. For information on the disposal of unused, unwanted product, contact the Provincial Regulatory Agency or the manufacturer. Contact the manufacturer and the Provincial Regulatory Agency in case of a spill, and for clean-up of spills.

PHYSICAL AND CHEMICAL HAZARDS: Mix only with water. Use clean, dry utensils and equipment. Do not add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire and explosion.

ENVIRONMENTAL HAZARDS: This product is toxic to fish. Do not discharge where it will drain into lakes, streams, ponds or public waters.

NOTICE TO USER: This pest control product is to be used only in accordance with the directions on the label. It is an offence under *the Pest Control Products Act* to use this product in a way that is inconsistent with the directions on the label.
