**DIRECTIONS FOR USE: FOR INDOOR USE AT BUILDINGS AS A SPACE SPRAY OR ON INDOOR ORNAMENTAL HOUSEPLANTS.** Use ONLY in a well-ventilated area. SHAKE WELL BEFORE USING. Press button firmly to spray. To enhance effectiveness of this product, apply directly to the listed pests where possible. For all labelled uses, treatment must only be repeated after 7 days if pest problem persists or reoccurs. Good sanitary practices should be maintained to prevent re-infestation.

**USE LIMITATIONS FOR INDOOR USE AT BUILDINGS: DO NOT** apply when people or pets are present. **DO NOT** allow people or pets to enter treated areas until sprays have settled or dried. **DO NOT** apply to surfaces that may come into contact with food/feed. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash them following treatment. Any food/feed accidentally contaminated with spray solution must be discarded. Ventilate treated areas after application by opening windows and doors or using fans, where required, to aid in the circulation of air.

**INSTRUCTIONS FOR SPACE SPRAY APPLICATION:** Apply as a space spray ONLY. **Space application** is a suspension of fine droplets in the air within an indoor space. To kill biting midges, flies, hornets, mosquitoes and wasps: close all windows and doors and shut off all ventilating systems and sources of ignition before treatment. While holding can at arm's length, spray upward to all parts of the room, especially ceiling, upper corners of the room, windows and other light sources. Keep spray at least 120 cm from interior walls, fabrics and furniture. Begin application at far side of the room and work backwards toward exit. **DO NOT** exceed 0.29 seconds of spray time per m<sup>3</sup> of room space, per average sized room (30 m<sup>3</sup>). Vacate the treated area and keep windows and doors closed for 15 minutes, then ventilate thoroughly before re-entry.

**INSTRUCTIONS FOR USE ON INDOOR ORNAMENTAL HOUSEPLANTS:** To kill Aphids, Two-spotted Spider Mites and Adult White Flies on the following houseplants: African Violets, Aralia, Christmas Cherry, Chrysanthemum, Cineraria, Diffenbachia, Fuschia, Gloxinia, Ivy, Lantana, Neathe Bella Palm, Petunia, Rose & Snapdragon. **DO NOT** apply to houseplants grown for food or feed (e.g., herbs). **DO NOT** use on greenhouse plants. When listed pests first appear, spray to thoroughly cover all foliage, including upper and lower leaf surfaces until damp. **DO NOT** wet plants to the point of runoff or drip. **DO NOT** exceed 2.4 seconds of spray time per m<sup>2</sup>. Use with caution on new growth and tender foliage. Test on one or two leaves to determine safety.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. DO NOT** remain in treated areas after application. Contents under pressure. **DO NOT** place in hot water or near radiators, stoves or other sources of heat. Cover fish bowls when spraying rooms. Avoid contact with skin, eyes or clothing. Avoid inhalation of spray. Wash after using. **DO NOT** use on Maiden Hair ferns.

**FIRST AID: If in eyes,** hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If on skin or clothing,** take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **If inhaled,** move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth,

if possible. Call a poison control centre or doctor for further treatment advice. **If swallowed**, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Skin exposure may cause transient sensations (tingling, burning, itching, numbness). Other symptoms of exposure could include respiratory effects (such as cough, respiratory irritation, or shortness of breath), nausea, headache or dizziness.
