FIRST AID

IN CASE OF POISONING, contact a physician or a poison control centre **IMMEDIATELY**. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

If on skin or clothing, take off contaminated clothing. Rinse skin **IMMEDIATELY** with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If swallowed, call a poison control centre or doctor **IMMEDIATELY** for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Potential skin sensitizer. Harmful if inhaled.

Strictly observe all precautions for handling and using pesticides. Avoid contact with skin, eyes and clothing. Avoid inhalation of dust. Do not eat, drink or smoke while working.

Do not contaminate food, feed or water supplies.

-Protective Equipment:

Heavy duty cotton or synthetic fabric working clothes (e.g. coveralls). Rubber apron. Heavy-duty shoes or boots. Chemical resistant gloves. Goggles or face-shield. In case of heavy exposure wear: Dust mask.
