#### **DIRECTION FOR USE:**

BLACKWATER: Add 0.33 mL of **RV-Boss** <sup>TM</sup> **Holding Tank Treatment** – **Concentrated Formula** per 1 L of tank volume. For example, to treat 90 liters (20 gal), pour 30 ml (1 oz.) of **RV-Boss** <sup>TM</sup> **Holding Tank Treatment** – **Concentrated Formula** in the toilet bowl.

GREYWATER: Add 0.17 mL of **RV-Boss** <sup>TM</sup> **Holding Tank Treatment** – **Concentrated Formula** per 1 L of tank volume.
