DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the Pest Control Products Act.

The technical is a gas and must be formulated immediately into the end use product.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Avoid contact with eyes, skin, and clothing. May irritate eyes. May be harmful if inhaled. Avoid breathing vapours. Wear a mask or an approved pesticide respirator. Wash contaminated clothing separately before reuse. Wash thoroughly with soap and water after handling and before eating or smoking.

STORAGE:

The technical is a gas and cannot be stored, and must be immediately formulated into the end use product.

DISPOSAL:

FIRST AID:

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.
