## **DIRECTIONS FOR USE**

To be used only in the manufacture of a microbiocide which is registered under the *Pest Control Products Act*.

## **FIRST AID**

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

## **PRECAUTIONS**

### **PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.**

Corrosive to eyes and skin. Fatal if swallowed. Potential skin sensitiser. Do not swallow. Do not inhale dust. Do not get in eyes, on skin or on clothing. Avoid contamination of food. Wear chemical resistant gloves when handling the product.

Stay away from:

- (a) Oxidising materials.
- (b) Heat and sources of ignition.
- (c) Food and food containers. Avoid contact with metals.

Spillage: Immediately sweep up and remove; then clean the area with detergent and water.

## **STORAGE**

Store away from oxidizing materials, heat and sources of ignition. Store away from food and food containers. Avoid contact with metals.

## **DISPOSAL**
