**DIRECTIONS FOR USE:** To be used only in the manufacture of a herbicide which is registered under the *PEST CONTROL PRODUCTS ACT*.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN AND UNAUTHORIZED PERSONNEL. Hazard to humans and domestic animals. Harmful if swallowed. Avoid contact with skin, eyes and clothing. Do not inhale vapours. Store the container away from seeds, fertilizer, plants and foodstuffs. Wash concentrate from skin or eyes immediately. After handling wash hands and other exposed skin. Avoid contamination of ponds, streams, rivers and other water sources. Wear chemically resistant nitrile gloves, e.g., Edmont Sol Vex #37-155/#37-145 or Pioneer A-15. Gloves which are in good condition must be worn when handling product. Goggles should be worn when handling Bromoxynil Octanoate.

# FIRST AID:

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**IF INHALED**: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

ENVIRONMENTAL PRECAUTIONS: Do not contaminate water used for irrigation, domestic purposes. DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

**STORAGE:** Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed, feed, fertilizer, or other pesticides. Keep away from fire or open flame, or other source of heat.

**DISPOSAL:** Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal or provincial regulations. For additional details and clean- up of spills, contact the manufacturer and the provincial regulatory agency.

**SPILLAGE CLEAN-UP:** Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

Keep by-standers away. Do not smoke, drink or eat during clean-up operations. Wear protective equipment (respirator, coveralls, rubber boots and protective gloves) and sweep up all product and shovel into a drum. Dampen spilled product and use absorbent sweeping compound to prevent dust. Add broken packages to the drum and seal for removal to an approved disposal site.

Wash spill site with water and mop up into a drum for disposal to an approved disposal site. Remove and wash all protective clothing and equipment. Shower and wash thoroughly with soap and water on completion of mopping up operation. For details on spill cleaning contact the provincial regulatory agency or the manufacturer.
