DIRECTIONS FOR USE

The V2 Net contains metallic copper embedded in high-density polyethylene and is designed for use in aquaculture as a fish containment and anti-predator protection net in fish farms. The V2 Net is effective in preventing growth of hydroids, barnacles, mussels and other organisms and can be used in fresh, brackish and marine waters. The antifouling properties of the net allows for longer *in situ* cleaning intervals.

The V2 Net is fabricated based on the dimensions provided by the customer or user in Canada. The V2 Net can be used exactly as any other aquaculture cage net. The density of the V2 Net should alleviate the need for additional sinker weights to make it negatively buoyant and operationally easier to handle.
