**DIRECTIONS FOR USE:**

To be used only in the manufacture of a garlic based insect repellent which is registered under the *Pest Control Products Act*.

**PRECAUTIONS:**

**PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.** Harmful if swallowed. DO NOT get in eyes. Cause eye irritation. DO NOT get on skin. Severely irritating to the skin. Avoid inhaling/breathing mist or vapours. Potential skin sensitizer. DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

**FIRST AID:**

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for treatment advice.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**STORAGE:**

Store containers tightly closed, out of direct sunlight, at temperatures between 4° and 20° C. Cooler storage temperatures are preferred.

**DISPOSAL**
