DIRECTIONS FOR USE:

RESTRICTIONS:

- DO NOT apply to any body of water.
- DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
- Avoid application of this product when winds are gusty.
- DO NOT apply when people, pets or livestock are present. Cover fish bowls before spraying.
- DO NOT allow people, pets or livestock to enter treated areas until sprays have dried.
- DO NOT allow spray to drip or allow drift onto non-target surfaces.
- DO NOT apply to people, pets, livestock or sources of electricity.
- DO NOT apply to furniture (excluding bookcases and storage furniture), mattresses, linens, toys, or clothing.
- DO NOT apply to overhead areas or in confined spaces (e.g., attics, crawlspaces)
- Ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air. Air exchange/ventilation systems confirmed to be operational may also be used.
- DO NOT apply to plants grown for food or feed (e.g., vegetables, fruit, herbs) or in areas where these plants are grown. When applied to the exterior surfaces of buildings, garbage cans and on patios, porches and decks, DO NOT treat soil, turf or other plants adjacent to the treatment site.
- DO NOT transfer product to another container.
- DO NOT apply as a space spray or broadcast application.
- DO NOT contaminate food or feed. DO NOT spray food/feed or food/feed packages. DO NOT apply to surfaces that may come into contact with food/feed.
- The application of this product to vinyl and aluminum siding (particularly lightly coloured, aged, weathered or otherwise damaged) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Before applying, treat a small area of the siding and evaluate 30 minutes later to allow any potential staining to occur. Never apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of day.
- This product may stain or damage certain plastic, rubber and asphalt materials such as tiles, shingles, floor covering and carpets. Apply with caution to surfaces and avoid excessive wetting.
- Do not apply to draperies, tapestries, wallpaper or similar materials that may be stained.
- For all other surfaces, test a small inconspicuous area of the surface to be treated for color fastness & staining before full application.

HOW TO APPLY

SHAKE WELL BEFORE USING. Apply with attached battery-operated sprayer. Adjust nozzle to suitable spray pattern.

INSTRUCTIONS FOR BATTERY-OPERATED WAND OR TOP GUN TRIGGER SPRAYER

1. Remove sprayer from side clip. Unwrap hose completely. (Illustration 1)

2. Remove protective strip from battery compartment to activate batteries. (Illustration 2)
3. Insert hose attached to sprayer into the jug and tighten cap. Turn to “ON” position. (Illustration 3)
4. Flip open Wand sprayer until it locks into position or remove Top Gun Trigger sprayer from holster. (Illustration 4)
5. Twist nozzle at end of Wand sprayer or Top Gun Trigger sprayer to desired spray pattern. Ensure trigger lock is disengaged before spraying. Hold trigger for continuous spray. (Illustration 5)

NOTE: Do not submerge in water. When storing sprayer for long periods, remove batteries. To replace batteries, open battery compartment at bottom of applicator handle. Remove used batteries and replace with new AA batteries in correct position as marked per diagram inside battery compartment. Securely close battery compartment door. Always use a complete set of the same type when replacing batteries. Never mix alkaline, carbon-zinc or rechargeable batteries.

DO NOT APPLY AS A SPACE SPRAY OR BROADCAST APPLICATION.

Apply as a crack and crevice or spot treatment only.

SPOT TREATMENT is localized to surface area not more than 0.2 m². Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room.

CRACK AND CREVICE is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

INDOOR APPLICATION TO CONTROL ANTS, COCKROACHES, CRICKETS, FIREBRATS, SILVERFISH, SOWBUGS, SPIDERS, RED FLOUR BEETLES, AND RICE WEEVILS:

Thoroughly treat inside building surfaces, including cracks, crevices in walls, floors and ceilings; along and behind baseboards; around water pipes and tanks; walls behind and floors beneath appliances (e.g., refrigerators and stoves) and furniture (e.g., shelves, drawers, cabinets and storage units); around sinks, drains and pipes; around garbage containers; around interior foundations; localized area around garbage cans; localized areas of floors and floor coverings and points of entry (e.g., around windows and doors). Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

FOR SILVERFISH, also spray the cracks and crevices in bookcases. Remove all objects before treatment of bookcases where books, clothing, toys, towels and other items are stored. Treated bookcases must be dry before replacing stored items. Treatment must only be repeated after 7 days if pest problem persists or reoccurs

FOR ANTS, also spray trails and nests. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

TO CONTROL CARPET BEETLES: Spray edges of carpeting and under carpeting and rugs. Make localized application to floor and baseboards. Spray directly into cracks, crevices and infested areas of shelving. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

TO CONTROL CLOTHES MOTHS: Remove all objects before treatment of bookcases, closets or other types of storage furniture where clothing, toys, towels and other items are stored. Remove any infested articles from storage, brush thoroughly and air for several hours in sunlight, if possible. Apply spray to empty chests, closets, bureaus and other storage areas, directing the spray into cracks, joints and crevices. Treated furniture must be dry before replacing stored items. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

TO CONTROL FLEAS (ADULT AND LARVAE) AND AMERICAN AND BROWN DOG TICKS (ADULT AND NYMPHS): DO NOT apply to furniture, mattresses, linens, toys or clothing. Apply to indoor building surfaces, including cracks and crevices in walls and floors, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings. Pet bedding may be entirely treated with this product and replaced with clean, fresh bedding after other listed areas are treated. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

DO NOT SPRAY PETS WITH THIS PRODUCT. Only treat pets with products specifically registered for use on that type of pet. For effective flea and tick control indoors, clean any area used by the pet. Cleaning the areas includes vacuuming floors, carpets, furniture, etc. (discard vacuum bag after use) and washing the pet's bedding, living quarters, and surrounding area.

TO CONTROL BED BUGS: DO NOT apply to the mattress, headboard, footboard or furniture. Apply to inside building surfaces including cracks and crevices in the walls, floors and ceilings; along and behind baseboards and mouldings, and localized areas of walls behind and floors beneath furniture (e.g., bed and nightstand). To enhance effectiveness of this product, apply directly to bed bugs where possible. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

OUTDOOR APPLICATION ON THE EXTERIOR SURFACES OF BUILDINGS AND PATIOS, PORCHES, AND DECKS: To Control Ants, Crickets, Fleas, House Flies, Spiders, Sowbugs and Brown Dog and American Dog Ticks: Apply to the outside surfaces of foundations, under eaves troughs, around light fixtures, and places where listed pests enter (e.g., screens, doors, window frames). This product may also be applied to garbage cans and localized areas of patios, porches and decks. For house flies, apply as a spot treatment only. Houseflies will be killed when they land and crawl on the treated surfaces.

For ants, spray onto ant trails, into ant nests and points of entry.

For spiders, apply the exterior surfaces of buildings and on patios, porches and decks including under eaves, awnings and canopies.

Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

GENERAL OUTDOOR APPLICATION

To help control ticks in outdoor activity areas, treat a band of vegetation and leaf litter 1.8 to 3 metres (6-10 feet) wide and adjacent to activity areas, especially where dense vegetation occurs. DO NOT apply to plants grown for food or feed (e.g., fruits, vegetables, herbs). Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Wash thoroughly after handling and before smoking or eating.

ENVIRONMENTAL PRECAUTIONS: Toxic to aquatic organisms, birds, bees, and beneficial insects.

FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Have person sip a glass of water if able to swallow. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and PCP Registration Number with you when seeking medical attention.

DISPOSAL:

Do not re-use empty container. Wrap and dispose of empty container in household garbage.

STORAGE:

Store in a cool dry area away from heat. Store this product away from food or feed" here.
