Concentrated disinfectant cleaner deodorizes with a light pine
scent. It disinfects and kills a wide a wide range of bacteria
on hard surface areas. Use GERM-TROL CONCENTRATE to prevent mold
and mildew on hard, non-porous surfaces too.

DIRECTIONS: TO CLEAN, DISINFECT AND DEODORIZE hard non porous surfaces such as floors, walls, sinks, tubs, showers, toilets, drains, closets, bed and crib frames, diaper pails, telephones, pet kennels, and cages, garbage pails dilute and apply as follows. For heavily soiled surfaces, a pre-cleaning step is required and recommended. Prepare a fresh solution for each use. Mix 80 mL GERM-TROL per each 10 L of water. (2.5 TBSP or 1.3 oz/imp gal.). Clean all surfaces thoroughly and leave wet for ten minutes before wiping dry or Mix 8 mL per each 1 litre of water in a pump spray bottle. Spray on, wait 10 minutes. Wipe off.

TO PREVENT MOLDS AND MILDEW ON HARD NON-POROUS SURFACES In shower stalls and other damp musty places mix 80 mL per 10 litres of water. (2.5 TBSP or 1.3 oz/imp gal.). Apply the solution with a sponge to a cleaned surface. Wet surface completely and let surface air dry. Do not wipe off. Repeat weekly or if mildew reappears.

TO SANITIZE PREVIOUSLY CLEANED AND RINSED DISHWARE AND HARD NON-POROUS FOOD PREPARATION SURFACES such as Glasses, Eating Utensils, Plates, Countertops, Chopping Blocks, Mix 22 mL per 10 litres of water. (2 tsp or 0.35 oz/imp gal) Clean surface by wetting with sponge and letting air dry or immersing completely for 60 seconds, removing and letting air dry. Rinse Treated surface or utensil thoroughly with drinking water before use.

CAUTION: All food surfaces such as work surfaces and processing equipment must be rinsed with potable water before re-use. Avoid contamination of food in the application and storage of the product.
