These contents will make 45 L of dilute spray, enough to cover 94 m² of area.

META LIQUID SLUG & SNAIL KILLER DESTROYS SLUGS THAT CRAWL OVER SURFACES WHICH HAVE BEEN SPRAYED. UNLIKE A BAIT, IT DOES NOT HAVE TO BE EATEN BY THE SLUG TO BE EFFECTIVE. GOOD RESULTS ARE OBTAINED BY APPLYING THE SPRAY TO AREAS ADJACENT TO SLUG HIDING PLACES, KILLING SLUGS AS THEY MIGRATE TO FOOD SOURCES.

DIRECTIONS FOR USE:

Shake before using. Mix 30 mL (2 tablespoons) of Meta Liquid Slug & Snail Killer to 5 L of water and apply to 10 m² of area. Do not allow animals to graze on treated area within 1 - 2 weeks.

LAWNS & ORNAMENTALS: May be applied with a sprayer or a sprinkling can. Apply to areas frequented by slugs. The spray may be applied to the foliage of ornamentals.

VEGETABLES: Spray a barrier ring around your vegetable garden to protect it from outside invasion. One litre of spray will make a barrier 30 cm wide by 7 m long.

DO NOT SPRAY ON THE EDIBLE PARTS OF VEGETABLES.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN, POULTRY AND DOMESTIC ANIMALS. Avoid inhalation of the spray mist. Keep away from eyes. Avoid contamination of food and feedstuff. Protect contents from freezing. Do not store in direct sunlight or near food. Do not contaminate lakes, ponds, streams or rivers.

FIRST AID: IF SWALLOWED, induce vomiting by giving 2 glasses of water to drink and inserting finger into the mouth and touching the back of the throat. Repeat until vomit fluid is clear. Call a doctor or poison control centre immediately. Never give anything by mouth to an unconscious person. IF IN EYES, flush with water for 15 minutes and get medical attention. IF ON SKIN, remove contaminated clothing and wash skin with soap and water.

TOXICOLOGICAL INFORMATION: Ingestion may cause intestinal irritation, and kidney and liver damage.

STORAGE: Keep product in original container. Store in a cool, dry place away from food.

DISPOSAL: Do not re-use empty container. Wrap container and discard in household garbage.
