FIRST AID

DIRECTIONS FOR USE

SHAKE WELL BEFORE USING.

PENTAC AQUAFLOW MITICIDE is a specific miticide effective against most phytophagous species including Two-Spotted Spider, European Red and Broad Mites.

GENERAL USE INSTRUCTIONS: Add recommended amount of PENTAC AQUAFLOW MITICIDE to partially filled tank of water, then complete filling and mix well before spraying. Use dilute spray mixture within 24 hours.

RECOMMENDED APPLICATION

DO NOT APPLY TO EDIBLE CROPS

Pentac Aquaflow is recommended for use on most ornamental

plants including those listed below:

GROUP I: (Greenhouse & Indoor Ornamentals)

Rose, Chrysanthemum, Poinsettia, Carnation,
Snapdragon, Palm, Maranta, Aphelandra, Croton,
Dieffenbachia, Schefflera, Pothos, Aglaonema,
Succulents and Gardenia.

GROUP II: (Outdoor Ornamentals & Nursery Stock)
Arborvitae, Hemlock, Spruce, Birch, Dogwood, Azalea,
Taxus, Evergreen Trees, Garden Mums, Snapdragons,
Zinnia, Delphinium, Roses and Miniature Roses.

GREENHOUSE USE (GROUP I):

Apply PENTAC AQUAFLOW MITICIDE at 65 mL per 100 litres of water. Spray foliage to run-off. If heavy mite populations persist, repeat application at seven (7) days intervals.

OUTDOOR USE (GROUP II):

Apply at 1.2 litres per hectare in sufficient water to spray foliage to run-off. Assure complete coverage by directing spray to upper and lower leaf surfaces. Repeat at seven (7) day intervals. If heavy mite populations persist, repeat application at five (5) day intervals.

INTERIOR & PLANTSCAPE USE (GROUP I):

Apply at 0.75 mL per litre of water. Mix well before spraying. Thoroughly wet upper and lower leaf surfaces, spraying foliage to run-off. When heavy mite populations exist, a second application seven (7) days later is needed for optimum control. AVOID spraying wall coverings, plastic (vinyl) surfaces, drapes, carpets, and upholstery.
