DIRECTIONS FOR USE

GENERAL DIRECTIONS:

Place baits in locations where rats and mice feed, water and/or travel. Bait placements along walls, in corners and in concealed locations where rats and mice can feed unobserved are desirable. Contaminated or spoiled baits should be replaced promptly. Protect bait against access of children, pets, livestock and wildlife, preferably using bait stations or tamper proof boxes.

Tablespoon amounts (10-15 g) of bait at 3 to 4 metre intervals. An uninterrupted supply of bait should be maintained for at least 15 days.
