HOW TO IMPREGNATE YOUR JACKET

1. Open the bag and squirt the solution over one entire side of the visible fabric, using approximately 1/2 of one bottle of Shoo-Bug (T) Repellent Solution.
2. Turn Storage Bag over.
3. Squirt the solution over the other side of the visible fabric with remaining half of that bottle of the Repellent.
4. Be sure to use one full bottle of the Repellent.
5. Close Storage Bag with snaps as shown (Extra bottle of Shoo-Bug (T) Repellent Solution may also be stored in this bag).
6. Leave Jacket inside the closed Storage Bag for at least 12 hours.

DIRECTIONS FOR WEARING

1. After impregnation, and after at least 12 hours of storage in the closed bag, remove Jacket from Storage Bag, and hang up to air for at least one hour prior to wearing. (It is only necessary to air your Jacket once after each impregnation.)
2. Wear over shirt or other outdoor clothing.
3. Sleeves are designed to be worn over hands for more protection, or snapped back around wrists.
4. Hood may be worn over hat or head during severe insect infestations.
5. Return Jacket to Storage Bag and snap it closed after each use to prolong life of Repellent.

DIRECTION FOR USE OF REPELLENT SOLUTION

To repel insects, impregnate Jacket as directed. Return Jacket to Storage Bag after each use. For added protection, apply small quantities as directed to skin and or socks, pants, or other clothing.
